- Kara: Want to offer updates and information, will provide officer and chief rep updates, committee appointments and leave time for Q&A
- Jeremy: Reasonable to expect to hear from members, "The past group in office said XYZ" –
 if that happens we need to ask for them to show us that information in writing or show us
 the MOU
- Encourage people to engage with all colleagues rather than just one person discuss strategies on how to organize, write your own petitions
- Kris: suggested to have slides ready to post after the fact, as this have been requested in the
 past
 - o Kara: Planning to post slides and bulleted points of topics to share
 - Will plan to post Monday or Tuesday following
- Specifics for WRC Training
 - o A few WAC members along with Lori Pelham to teach courses
 - Unsure if being recorded, Kara will clarify with Lori
- Discussion on whether we should record GMMs:
 - Could see how 0800 2/21 goes and consider recording 1200 2/22
 - Kris: Unless it's a webinar, we typically need everyone's permission to record. It's one thing to record presentation, but would want to avoid recording Q&A
 - Could post under password protection for members to view if unable to attend
 - Concern about wanting to provide a safe space for members to ask potentially private questions and not have that public information

- If we can't address everything we can send out answers to questions w/ FAQ and send out

- Ernie shared excel with expenditures hot topic for some, how do we want to share?
 - Julia Talked with Andrew and Will about how much we're required to release in terms of finances
 - We can say this is an overview of how much we'll take in, here's our current expenditures. Members don't necessarily need to hear breakdown, such as stickers costing \$30
 - We are not required to post anything on any website
 - Overview at GMM is completely appropriate
 - Could consider modeling after ACLC

 - Careful about anti-union organizations that might use info against us
