- a. Kara update 1<sup>st</sup> week in office: Update on 2018 parking changes Unfair Labor Practice (ULP) - the employer was ordered to return parking spots they changed in 2018, once returning spots, they changed other parking spaces. Tim has filed an information request and we are pushing back on these new changes that occurred without bargaining.
- b. First Joint Implementation Team (JIT) meeting mostly a check in with the new team: discussed ambulatory care concerns, Blitz being forced overtime in some units, clarification around OT, holiday sign-up, and workload appointment issues
  - i. Lori Pelham is reaching out to Clinical Nurse Directors (CNDs) clarifying that Blitz should be part of your appointment, and not done as forced overtime
